3. Profile of skills and competences

- Apply occupational safety measures when handling machines, devices and tools for the manufacture, treatment, processing and shaping of glass and disposal of waste glass and other materials at designated disposal sites or civic amenity sites
- Create technical specifications for glass works
- Control the quality of glass before the start of treatment
- Treat glass with machines, devices and tools for glass treatment according to technical documentation
- Manufacture glass products with machines, devices and tools for treatment, processing and shaping glass and manufacture glass to the appropriate size by cutting and grinding edges
- Install glass products on buildings and glaze structures intended for glazing
- Install insulating glass and fix it by installing decorative mouldings
- Dismantle the moulding when installing glass in a plastic/aluminium/wooden structure
- Place the pad on the wooden/metal structure and cut out the picture frame using a machine, depending on the material and profile of the frame
- Grind the glass (by using numerically controlled machine or manually) according to the documentation related to the purpose of installation (e.g. for stained glass windows, for sacral objects, for furniture, for wall coverings, glass walls, glass fences, vehicle windows, licitar products, etc.) and execute sandblasting of the glass
- Contract glass works and communicate with clients, colleagues and suppliers in accordance with the rules of business etiquette

4. Range of occupations accessible to the holder of the certificate

A glazier performs tasks of technical and technological preparation of work, treatment, processing and shaping of glass, management of CNC machine for glass treatment, manufacture of various types of glass products, assembly and installation of glass products in/on buildings and glazing of structures. Employment possibility is at workplaces in construction, glass workshops, companies whose primary activity is the production of glass accessories, etc. Self-employment is possible by setting up a glass workshop. During the performance of work, it is necessary to use means of personal protection and protection at work appropriate for the workplace and the work being performed.
