4. Range of occupations accessible to the holder of the certificate

The CNC operator performs the tasks of programming simple work operations, independently starting, servicing, controlling and managing the work of numerically controlled machine tools. The CNC operator uses technical and technological documentation, measuring equipment and tools. Prepares raw materials and calibrates tools, controls workpiece dimensions and quality of finished products. During work, prepares, monitors and supervises the machine's operation process and performs a simple check of the CNC machine functionality. The CNC operator works mostly in the metalworking industry, and with the acquired competences, can work on the manufacturing of products from wood, stone, glass, etc.
